#### 1. Brief History & Current Context

A plan to leverage existing community support

Since 2013 the Gannawarra Solar Farm has enjoyed and sustained widespread community support within the local shire jurisdiction, predominantly in and around the Kerang township.

This support extends further afield across the wider Mallee Region of Northern Victoria including larger towns such as Swan Hill, as well as to the south through the Project's positive engagement of local community entities such as the Bendigo Sustainability Group.

It's testament to this positive local context that - after proactively conducting personal meetings with those adjoining neighbours who raised matters of concern - the Project then received no appeals during the relevant planning approval process. Community perceptions of the Project site are enhanced by its unobtrusive location, being conveniently screened from passing motorists by an existing 25m wide buffer of well-established trees along the site's frontage to municipal Lalbert-Kerang Rd. This Community Engagement Plan (CEP) builds upon this existing good will, and provides a framework to regularly – and proactively – engage and consult with a wide spectrum of local entities and individuals, and to bring the community along with the Project's journey.

Gannawarra Solar Farm Pty Ltd benefits from a depth of experience in successful community consultation within its consortium, both through the founder of Edify Energy (who led the financing and construction of over 20 utility solar farms across the UK between 2011 to 2015) as well as Bougygues extensive experience as one of the world's largest infrastructure firms.

Additionally, Solar Choice's impartial residential model has productively served many hundreds of residents in and around Kerang, Swan Hill, Bendigo and the wider Mallee region with informative Quote Comparisons for residential solar and battery storage options since 2008, and is a well-respected name in these communities.

#### 2. Key Objectives

This CEP will focus on the following key objectives:

- A. Collaborative and proactive dialogue with neighbours in close vicinity to the Project site.
- B. Wider community engagement and interaction through regular public meetings and Q&A sessions at all stages of the Project at Kerang Memorial Hall.
- C. Education opportunities through site tours with local Schools, training and education bodies, as well as local indigenous groups.
- D. Interaction, engagement and involvement with a diverse spectrum of local stakeholders and interested entities.

### 3. Plan to achieve Objective A

Collaborative and proactive dialogue with neighbours in close vicinity to the Project site.

During the 2013 public notification period for the planning application, Solar Choice arranged and attended individual meetings at the homes of six neighbours in close vicinity to the Project site to listen to their various concerns, and to address them in a response paper provided to Council.

Following these proactive meetings, no appeals were lodged against the project during the relevant period following the successful granting of the Planning Permit, however the Project recognises that these neighbours no doubt still hold ongoing reservations that need to be engaged in the lead up to construction, during construction and then for the long term life of the Gannawarra Solar Farm.

Under this CEP, the Project will continue this direct, personal and collaborative dialogue with all of these six groups of neighbouring landowners, plus any others in close vicinity to the project who may raise similar matters of concern in future, through the following three key methods:

- i. Direct and personal provision of clear information about the Project's progress by phone, email and/or where possible in additional individual meetings at the homes of these nearby landowners;
- ii. Actively listen to the concerns of neighbouring landowners, and subsequent follow up by email to the landowners confirming that their concern has been noted and registered;

iii. Incorporate feedback from neighbouring landowners where appropriate into the Environmental Management Plan,Landscape Management Plan and/or Fire Management Plan for the Project.

The original 2013 concerns of each these six neighbouring property owners that will need to be continually addressed under this CEP are set out in Figure 3.1 below.

These meetings will be open to all members of the public to attend as an open forum though which to learn about the Project's progress, and to have their free say.

It's anticipated that these meetings will also allow a conduit to engagement of subcontractors, or other job opportunities either directly or indirectly engaged in the project.

The meetings will be convened and chaired by a representative of the Project.

A list of names and email contacts of all attendees who wish to register will be taken, and minutes of each meeting disseminate to them within seven calendar days.

Any specific matters that the community would like addressed by the Project can then be tabled to the Directors of Gannawarra Solar Farm Pty Ltd, and subsequent resolution of any action relayed to the list of attendees.

### 5. Plan to achieve Objective C

Education opportunities through site tours with local Schools, training and education bodies, as well as local indigenous groups.

The Project has already proactively notified a range of Schools and other education and training entities in the local region of the educational and clean energy future benefits that the Gannawarra Solar Farm will bring to the region as Victoria's largest proposed photovoltaic generator.

Post construction, and where safe during construction at the discretion of EPC firm Bouygues, the project will conduct site tours for students and interested participants from local indigenous groups.

### Gannawarra Solar Farm commits to community consultation

Edify Energy & Solar Choice have plans in place to construct an initial ~60MW (DC) stage towards an ultimate ~300MW solar farm 12kms west of Kerang on the Lalbert-Kerang Road. Planning permits were issued in October 2013 and the company has been hard at work preparing for construction in 2017.

Gannawarra Solar Farm Pty Ltd has been shortlisted through the ARENA funding program and has commenced an intensive community consultation plan aimed at collaborating with local schools, local business groups, local service clubs and even the Bendigo Sustainability group. This broad range of community partnerships will ensure that everyone has the opportunity to learn more about renewable energy and will provide a chance for the community to develop a strong relationship with the solar farm.

The project's developers are excited by the enthusiasm that exists within the community firstly for the project and secondly for the environmental benefits the solar farm will provide. Kerang has a great range of built infrastructure to support large scale solar as well as great solar resources.

The relationships that Gannawarra Shire Council has with the local schools will provide the students with first-hand knowledge of how the solar farms operate and this will hopefully spur students on to careers in the renewable energy sectors. The students of today will play a key role in the future of Australia's energy resources and we are only too happy to share our industry knowledge.

The project is shovel ready with construction expected to commence in early 2017 providing around 220 jobs over a 14 month period, providing a huge economic boost and kick-starting the renewable energy sector for north west Victoria

Gannawarra mayor Cr Lorraine Learmonth said the solar projects planned for the Gannawarra Shire will be a significant boost to the local economy at a time when the fall out from the dairy pricing has eroded a lot of business confidence in rural Victoria.
